## Amateur Talent Contest

### 2010 Kean Idol Competition Details

**Location:**  
Kean Theatre  
The Washington Place at St. Barnabas  
5847 Meridian Road  
Gibsonia, PA 15044

#### Registration:

- Open to singers and dancers of all ages, non-professional (never paid to perform).
- \$25 registration fee for each registered act, performers are asked to sell 7 tickets to their preliminary round of competition to participate.
- Auditions are not required.

#### Tickets:

- Cost for admission is \$10.
- Ticket money must be submitted prior to competition.

#### Seating:

- There is no reserved seating; seats are available on a first-come, first-served basis.

#### Sound Check:

- Sound checks will be held for vocal and dance competition.

#### Vocal:

- Songs are limited to four (4) minutes.
- Four (4) people maximum in a group.
- Contestants are responsible to provide their own music: single-track only on CD with a backup CD.
- The condition of the CD is the responsibility of the contestant.
- Background vocals are not recommended, points will be deducted.
- **New: Adult Category! Age 19 and over.**

#### Dance:

- Dances are limited to three (3) minutes.
- Three (3) people maximum in a group.
- All dance styles accepted.
- Contestants are responsible to provide their own music: single-track only on CD with a backup CD.
- The condition of the CD is the responsibility of the contestant.

#### Competition:

- A minimum of ten (10) performers from each round will be selected from the judges' scores to perform a second time (using the same song/dance/music).
- The audience will choose a winner from each round of competition.

- A minimum of ten (10) performers from each round will advance to the semi-finals.
- A minimum of ten (10) performers from each semi-final will advance to the championship round.
- A second song selection will be required for the vocal championship round.

#### Judging:

- A panel of judges, not employed by St. Barnabas, will select the top finalists from each round.
- The audience will select the winner.
- Judges' scores will not be made public - comments, if provided, will be made available upon request
- Contestants will be judged on talent, stage presence, and presentation.

#### Ties:

- Ties will not be made public.
- Judges voting – in the case of a tie, then Kean Theatre management will make the final decision.
- Audience voting – in the case of a tie, the judges' ballots are the tie-breaker. If the judges' ballot are also a tie, then Kean Theatre management will make the final decision.

#### Redos:

- Contestants will have one opportunity to perform, with the exception of a major technical flaw such as a power outage, fire or flood.

#### Prizes:

- Medals will be given to the top winners at each round of competition.
- The "**Kean Idol**" title and grand prize will be awarded to the first place finisher in the dance and vocal segments.
- Secondary prizes will be issued to judge's choice, second- and third-place finishers during the championships.
- All contestants receive a certificate of participation.

#### Proceeds:
